Independent auditor report on the financial statements

To the shareholders of CHC Denmark ApS

Opinion

We have audited the financial statements of CHC Denmark ApS for the financial year 1 May 2019 – 30 April 2020, comprising income statement, balance sheet and notes, including accounting policies. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the Company's assets, liabilities and financial position at 30 April 2020 and of the results of the Company's operations for the financial year 1 May 2019 – 30 April 2020 in accordance with the Danish Financial Statements Act.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) and the additional requirements applicable in Denmark. Our responsibilities under those standards and requirements are further described in the "Auditor's responsibilities for the audit of the financial statements" section of our report. We are independent of the Company in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) and the additional requirements applicable in Denmark, and we have fulfilled our other ethical responsibilities in accordance with these rules and requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Management's responsibility for the financial statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with the Danish Financial Statements Act and for such internal control that Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting in preparing the financial statements unless Management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance as to whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern

Operating review

The Company's business review

The Company's main business activity was helicopter flying and related activities.

The company has been without activity since 2014.

Financial review

The income statement for 2019/20 shows a profit of DKK 36,521 against a profit of DKK 279,862 last year, and the balance sheet at 30 April 2020 shows a negative equity of DKK -40,552,861.

Special risks

The company is subject to the capital loss provisions in the Danish Private Companies Act.

The parent company EEA Helicopter Operations B.V., has confirmed that it will provide CHC Denmark ApS with financial support and assist CHC Denmark ApS in meeting their liabilities, as and when they fall due.

At 30 April 2020, equity amounted to DKK -40.553 thousand. The company has lost its equity and the company is therefore covered by the rules in the Danish company act regarding loss of capital. It is expected that the equity can be re-established on own initiative, alternatively by a capital injection.

The financial statements are presented on a going concern basis.

Post balance sheet events

No significant events have occurred subsequent to the financial year.

Notes to the financial statements

1. Accounting Policies

The annual report at CHC Denmark ApS for 2019/20 has been presented in accordance with the provisions of the Danish Financial Statements Act as regards reporting class B enterprises.

The accounting policies applied by the company are consistent with those of last year.

Income statement

Gross profit/loss

With reference to section 32 of the Danish Financial Statements Act, the items 'Revenue', 'Costs of sale', 'Other external expenses' and 'Other operating income' are consolidated into one item designated 'Gross profit/loss'.

Other external expenses

Other external expenses include the year's expenses relating to the entity's core activities, including expenses relating to distribution, sale, advertising, administration, premises, bad debts, payments under operation leases, etc.

Balance Sheet

Receivables

Receivables are measured at amortised cost.

An impairment loss is recognised if there is objective indication that a receivable or a group of receivables is impaired. If there is objective indication that an individual receivable has been impaired, write-down is made on individual basis.

Receivables with no objective indication of individual impairment are tested for objective indication of impairment on a portfolio basis. The portfolios are primarily composed on the basis of debtors' domicile and credit ratings in accordance with the Company's risk management policy. The objective indicators used for portfolios are determined based on historical loss experience.

Write downs are calculated as the difference between the carrying amount of receivables and the present value of the expected cash flows, including the realisable value of any collateral received. The effective interest rate for the individual receivable or portfolio is used as discount rate.

Liabilities

Financial liabilities are recognised at the date of borrowing at the net proceeds received less transaction costs paid. On subsequent recognition, financial liabilities are measured at amortised cost, corresponding to the capitalised value, using the effective interest rate. Accordingly, the difference between the proceeds and the nominal value is recognised in the income statement over the term of the loan. Financial liabilities also include the capitalised residual lease liability in respect of finance leases.

Other liabilities are measured at net realisable value.

2. Going concern

The company is subject to the capital loss provisions in the Danish Companies Act.

The company's continued operation is dependent on the parent company's financial support. The parent company, EEA Helicopter Operations B.V. has issued a letter of support towards the company about granting financial support to CHC Denmark ApS, so that the company is able to pay its liabilities, when they fall due. The commitment is valid until 12 months from the date of signing of these accounts.

As a result of the matters mentioned the supervisory board found it proper to prepare the financial statements according to the going concern principle.
