## Report on the financial statements

# Management's review

#### Main activity

The Company's main activity is to own shares in LM Group Holding A/S.

The company's ultimate parent company, which compiles the consolidated Financial statement in which the company appears as a subsidiary is LM WP III Holding S.á.r.l. ("LuxCo").

### Result for the year

Profit/loss for the year comprises a profit of DKK 397,867 thousand. The result is in line with what the management's expectations for the company was, at the beginning of the year.

#### **Expectations for the comming year**

The management expects that the activity levels for the company will remain the same for the coming financial period. The management expects the result for the coming financial period will be in line with what was seen in the result for the current period.

# **Accounting policies**

The Annual Report of LM WP Holdings A/S for 2015 has been prepared in accordance with the provisions of the Danish Financial Statements Act applying to enterprises of reporting class B as well as selected rules applying to reporting class C.

The annual report for 2015 is presented in T.DKK.

The accounting policies applied are consistent with those applied last year.

## Recognition and measurement

The Financial Statements have been prepared under the historical cost method.

Revenues are recognised in the income statement as earned. Furthermore, value adjustments of financial assets and liabilities measured at fair 'value or amortised costs are recognised. Moreover, all expenses incurred to achieve the earnings for the year are recognised in the income statement, including depreciation, amortisation, impairment losses and provisions as well as reversals due to changed accounting estimates of amounts that have previously been recognised in the income statement.

Assets are recognised in the balance sheet when it is probable that future economic benefits will flow to the Company and the value of the asset can be measured reliably.

Liabilities are recognised in the balance sheet when it is probable that future economic benefits will flow from the Company and the value of the liability can be measured reliably.

Assets and liabilities are initially measured at cost. Subsequently, assets and liabilities are measured as described for each item below.

Recognition and measurement take into account predictable losses and risks occurring before the presentation of the Annual Report which confirm or invalidate affairs and conditions existing at the balance sheet date.

## **Accounting policies**

#### **Consolidated Financial Statements**

With reference to section 112 of the Danish Statements Act, no consolidated financial statements are prepared for the sub-group LM WP Holdings A/S as the ultimate Parent Company, LM WP III Holding S.á.r.l. ("LuxCo"), prepares Consolidated Financial Statements for the entire Group.

### **Translation policies**

Transactions in foreign currencies are translated at the exchange rates at the dates of transaction. Gains and losses arising due to differences between the transaction date rates and the rates at the dates of payment are recognised in financial income and expenses in the income statement. Where foreign exchange transactions are considered hedging of future cash flows, the value adjustments are recognised directly in equity.

Receivables, payables and other monetary items in foreign currencies that have not been settled at the balance sheet date are translated at the exchange rates at the balance sheet date. Any differences between the exchange rates at the balance sheet date and the transaction date rates are recognised in financial income and expenses in the income statement.

#### **Income statement**

#### Other external costs

Other external costs comprise office expenses etc.

#### Financial income and expenses

Financial income and expenses are recognized in the income statement at the amounts relating to the financial year.

## **Accounting policies**

#### Tax on profit/loss for the year

Tax for the year consists of current tax for the year and deferred tax for the year. The tax attributable to the profit for the year is recognised in the income statement, whereas the tax attributable to equity transactions is recognised directly in equity.

The Company is jointly taxed with wholly owned Danish subsidiaries. The tax effect of the joint taxation is allocated to Danish enterprises in accordance to their taxable incomes.

## **Investments in subsidiaries**

Investments' in subsidiaries are measured at cost. Where the cost exceeds the recovable amount, write-down is made to this lower value.

#### Receivables

Receivables are recognised in the balance sheet at amortised cost, which substantially corresponds to nominal value. Provisions for estimated bad debts are made.

#### Current tax receivables and liabilities

Current tax liabilities and receivables are recognised in the balance sheet as the expected taxable income for the year adjusted for tax on taxable incomes for prior years and tax paid on account. Extra payments and repayment under the on-account taxation scheme are recognised in the income statement in financial income and expenses.

#### Financial debts

Other debts are measured at amortised cost, substantially corresponding to nominal value.
