# Ledelsesberetning

## HIGHLIGHTS

The main activity for CelVivo IVS is the design, production and commercialisation of high tech equipment for 3D cell culture.

This was the 4<sup>th</sup> year of operation for CelVivo IVS.

2017 was a good year for CelVivo IVS.

CelVivo IVS has made additional improvements to the equipment, some of which will safeguard the equipment against mis-use and other to the upgrading of components to ensure problem-free use. Other changes were enforced by changes to the available components. Several component simplifications have been made (without loss of functionality) which will facilitate the construction process.

CelVivo website has been updated frequently and visitors now have the option to enrol onto a newsletter ([www.CelVivo.com](http://www.CelVivo.com)). The website showcases our equipment. There are two videos: one showing what spheroids look like in culture and the other showing how easy it is to change the media in the bioreactor. Further demonstration videos are planned.

CelVivo IVS has entered into an agreement with BioImage Inc. They will be CelVivo's sole North American distributor. See: <http://www.bioimage.net>, Bio Image Systems, Inc. 721 Bloomfield, Jackson, MI 49203 USA.

CelVivo has replaced the instrument at the Tissue Culture Engineering laboratory (TCEL), Department of Biochemistry and Molecular Biology, University of Southern Denmark. The TCEL group continue to publish scientific articles illustrating the use of the CelVivo BAM and bioreactors.

CelVivo continues to sell and update BioArray Drive units around the world. Sales of the disposable bioreactor are increasing illustrating that customers are using the equipment to further their research.

CelVivo is now providing quotations to numerous scientists for inclusion in grant applications for National, International and EU research funding agencies (public and private). If/when funded this will result in further sales of our equipment.

CelVivo IVS has begun to establish itself on the market and as yet has still not developed anything that can be patented.

# Anvendt regnskabspraksis

Årsrapporten er aflagt i overensstemmelse med årsregnskabslovens bestemmelser for Regnskabsklasse B.

## **GENERALLY**

The annual report for CelVivo IVS has been prepared in accordance with the provisions of the Danish Financial Statements Act for a Class B company.

The annual report has been prepared in accordance with the same accounting policies as last year and is presented in Danish kroner.

## **INCOME STATEMENT**

The annual balance sheet is based on the sales the BAM drive unit, updates to the equipment and software, teaching courses and hotline services, equity of the owners, subcontractors and credits in the form of two BAM units, one of which is used as a demonstration unit and one being used as an alpha test unit.

## **OTHER EXTERNAL COSTS**

Other external costs include costs for administration of the company.

## **INCOME TAX EXPENSE**

Tax for the year, consisting of current corporate tax and change in deferred tax, is recognized in the income statement with the portion attributable to the profit for the year and directly to equity, with part attributable to entries directly to equity.

## **BALANCE SHEET**

Corporation tax and deferred tax

Current tax receivables and liabilities are recognized in the balance sheet with the amount that can be calculated on the basis of the expected taxable income for the year, adjusted for tax on previous years taxable income as well as for paid taxes.

Deferred tax is the tax on all temporary differences between the accounting and tax value of assets and liabilities calculated on the basis of the planned use of the asset or settlement of the liability.

Deferred tax is measured on the basis of the tax rules and tax rates that will be applicable at the balance sheet date when the deferred tax is expected to be triggered as current tax.

## **LIABILITIES**

Other liabilities are measured at amortized cost, which usually corresponds to the nominal value.
