Receivables are measured at nominal value.

Liabilities are measured at the nominal debt outstanding as of the balance sheet date.

There has been no value adjustment of assets and liabilities.

GROSS PROFIT

Gross profit is calculated based on sales less costs other than personnel costs. Revenue is stated net of VAT, taxes and discounts.

BALANCE

In this financial reporting period, there has been no accounting of depreciation, or deferral. Financial liabilities are recognized at face value.
