# Independent auditor's report

## To the owners of Homemate ApS

### Opinion

We have audited the financial statements of Homemate ApS for the financial year 01.01.2016 - 31.12.2016, which comprise the income statement, balance sheet, statement of changes in equity and notes, including a summary of significant accounting policies. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the Entity's financial position at 31.12.2016 and of the results of its operations for the financial year 01.01.2016 - 31.12.2016 in accordance with the Danish Financial Statements Act.

### Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) and additional requirements applicable in Denmark. Our responsibilities under those standards and requirements are further described in the Auditor's responsibilities for the audit of the financial statements section of this auditor's report. We are independent of the Entity in accordance with the International Ethics Standards Board of Accountants' Code of Ethics for Professional Accountants (IESBA Code) and the additional requirements applicable in Denmark, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

## Management commentary

### Primary activities

Homemate ApS ("Homemate") is an omnichannel (online/offline) retail food company that develops and distributes ready-to-cook food and related products. As of 31 December 2016, Homemate operated seven physical shops / pick-up points in Copenhagen, located at:

- Torvehallerne KBH Food Market
- Dag Hammarskjölds Allé 40, 2100 Copenhagen Ø
- Frederiksberg Allé 2-4 (near Værnedamsvej), 1820 Frederiksberg C
- Peter Bangs Vej 93 2000 Frederiksberg
- Jægersborg Allé 47, 2920 Charlottenlund
- Lyngby Hovedgade 76, 2800 Kongens Lyngby
- Vedbæk Stationsvej 19, 2950 Vedbæk

### Development in activities and finances

2016 marked the second year of operations of Homemate, following a successful test of the Company's ready-to-cook food products in Torvehallerne KBH Food Market during the Fall and Winter of 2014, and the subsequent launch of the first two shop locations during 2015 (Torvehallerne and Østerbro). During 2016, Homemate received follow-up financing from its core group of investors to finance the expansion of the Company's physical shops (from two to seven) and the pilot launch of the Company's e-commerce offering, as well investing in the development of the Company's production apparatus.

### Events after the balance sheet date

After the balance sheet date, Friheden Invest A/S, the family office behind apparel brand IC Group A/S, also joined the Company's investor base with a two-digit million DKK amount to help finance the expansion of the Company's retail reach and production capacity. Homemate has also opened one additional physical shop (located at Strandvejen 177, 2900 Hellerup), bringing the total number of physical shops / pick-up points to eight.

As of the signing of this annual report, Management believes that the Company will have sufficient funding to execute on its planned activities for the remainder of 2017, which includes the launching of multiple new physical shops as well as expanding its e-commerce solution and introducing home delivery.

### 7. Payables to shareholders and management

Payables to shareholders and management represents loans from shareholders which may in case of subscription of new share capital above a certain amount either be converted to equity at a discount to the share price of that round or repaid prior to maturity at terms to be agreed upon.

The loans from the shareholders including accrued interest are subordinated to the undrawn credit facility.

### 8. Contingent liabilities

Undrawn credit facility is secured by way of floating charge ("Virksomhedspant") of DKK 2.000.000.

## Accounting policies

### Reporting class

This annual report has been presented in accordance with the provisions of the Danish Financial Statements Act governing reporting class B enterprises.

The annual report has been presented applying the accounting policies consistently with last year.

### Recognition and measurement

Assets are recognised in the balance sheet when it is probable as a result of a prior event that future economic benefits will flow to the Entity, and the value of the asset can be measured reliably.

Liabilities are recognised in the balance sheet when the Entity has a legal or constructive obligation as a result of a prior event, and it is probable that future economic benefits will flow out of the Entity, and the value of the liability can be measured reliably.

On initial recognition, assets and liabilities are measured at cost. Measurement subsequent to initial recognition is effected as described below for each financial statement item.

Anticipated risks and losses that arise before the time of presentation of the annual report and that confirm or invalidate affairs and conditions existing at the balance sheet date are considered at recognition and measurement.

Income is recognised in the income statement when earned, whereas costs are recognised by the amounts attributable to this financial year.

### Foreign currency translation

On initial recognition, foreign currency transactions are translated applying the exchange rate at the transaction date. Receivables, payables and other monetary items denominated in foreign currencies that have not been settled at the balance sheet date are translated using the exchange rate at the balance sheet date. Exchange differences that arise between the rate at the transaction date and the one in effect at the payment date, or the rate at the balance sheet date are recognised in the income statement as financial income or financial expenses.

### Income statement

#### Gross profit or loss

Gross profit or loss comprises revenue, changes in inventories, other operating income, cost of raw materials and consumables and external expenses.

#### Revenue

Revenue is recognised in the income statement when delivery is made to the buyer. Revenue is recognised net of VAT, duties and sales discounts and is measured at fair value of the consideration received.



## Accounting policies

### Costs of raw materials and consumables

Costs of raw materials and consumables comprise the consumption of raw materials and consumables in the financial year after adjustment for changes in inventories of these goods from the beginning to the end of the year. This item includes shrinkage, if any, and ordinary write-downs.

### Other external expenses

Other external expenses include expenses relating to the Company's ordinary activities, including expenses for premises, marketing costs, start-up costs from the opening of new shops etc.

### Staff costs

Staff costs comprise salaries and wages as well as social security contributions, pension contributions, etc. for the Company's staff.

### Depreciation, amortisation and impairment losses

Amortisation, depreciation and impairment losses relating property, plant and equipment comprise amortisation, depreciation and impairment losses for the financial year, calculated on the basis of the residual values and useful lives of the individual assets and impairment testing.

### Other financial expenses

Other financial expenses comprise interest expenses, bank fees and tax surcharge under the Danish Tax Prepayment Scheme etc.

### Tax on profit/loss for the year

Tax for the year, which consists of current tax for the year and changes in deferred tax, is recognised in the income statement by the portion attributable to the profit for the year and recognised directly in equity by the portion attributable to entries directly in equity.

### Balance sheet

#### Property, plant and equipment

Leasehold improvements are measured at cost less accumulated depreciation and impairment losses.

Cost comprises the acquisition price, costs directly attributable to the acquisition and preparation costs of the asset until the time when it is ready to be put into operation. For assets held under finance leases, cost is the lower of the asset's fair value and present value of future lease payments.

The basis of depreciation is cost less estimated residual value after the end of useful life. Straight-line depreciation is made on the basis of the following estimated useful lives of the assets:

Leasehold improvements	3 years
Other fixtures and fittings, tools and equipment	3 years

## Accounting policies

### Inventories

Inventories are measured at the lower of cost using the net realisable value.

Cost consists of purchase price plus delivery costs. The net realisable value of inventories is calculated as the estimated selling price less completion costs and costs incurred to execute sale.

### Receivables

Receivables are measured at amortised cost, usually equalling nominal value less write-downs for bad and doubtful debts.

### Income tax payable or receivable

Current tax payable or receivable is recognised in the balance sheet, stated as tax calculated on this year's taxable income, adjusted for prepaid tax.

### Cash

Cash comprises cash in hand and bank deposits.

### Operating leases

Lease payments on operating leases are recognised on a straight-line basis in the income statement over the term of the lease.

### Other financial liabilities

Other financial liabilities are measured at amortised cost, which usually corresponds to nominal value.
