## Generally

In the income statement income as it is earned, including value adjustments of financial assets and liabilities. In the income statement All expenses, including depreciation and amortization. Assets are recognized in the balance sheet when it is probable that future economic benefits will flow to the company and the asset can be measured reliably. Liabilities are recognized in the balance sheet when it is probable that future economic benefits will flow from the company and the liability can be measured reliably. On initial recognition assets and liabilities at cost. Subsequently, assets and liabilities as described for each item below. Certain financial assets and liabilities are measured at amortized cost, implying the recognition of a constant effective interest rate to maturity. Amortized cost is calculated as original cost less any repayments plus / minus the accumulated amortization of the difference between cost and nominal amount. Recognition and measurement take into account predictable losses and risks arising before the annual report and that confirm or invalidate matters existing at the balance sheet date.

## Income statement

Revenue from the sale of commodities and finished goods are recognized in the income statement if delivery and transfer of risk to the buyer has taken place before year end. Revenue is recognized excl. VAT and net of discounts relating to sales.

Other operating income and expenses comprise items of a secondary nature relative to the company's main activity.

Other external expenses include expenses for distribution, sale, advertising, administration, premises, bad debts, operating leases etc..

Financial income and expenses are recognized in the income statement at the amounts relating to the financial year. Financial items include interest income and expense, financing costs of finance leases, realized and unrealized gains and losses on securities, debt and transactions in foreign currencies, amortization of mortgage loans and surcharges and allowances under the tax.

Dividends from investments in income in the year in which the dividend is declared.

Extraordinary income and expenses include income and expenses arising from events or transactions that are clearly distinct from the ordinary operations and are not expected to be of a recurring nature.

Income tax for the year comprises current tax and movements in deferred tax is recognized in the income statement with the portion attributable to the profit and directly in equity with the portion attributable to items recognized directly in equity.
