# Independent auditor's report

# TO THE SHAREHOLDERS OF Netcompany Holding ApS

### **OPINION**

We have audited the financial statements of Netcompany Holding ApS for the financial year 01.01.2017 - 31.12.2017, which comprise the income statement, balance sheet and notes, including a summary of significant accounting policies. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the Entity's financial position at 31.12.2017 and of the results of its operations for the financial year 01.01.2017 - 31.12.2017 in accordance with the Danish Financial Statements Act.

### **BASIS FOR OPINION**

We conducted our audit in accordance with International Standards on Auditing (ISAs) and additional requirements applicable in Denmark. Our responsibilities under those standards and requirements are further described in the Auditor's responsibilities for the audit of the financial statements section of this auditor's report. We are independent of the Entity in accordance with the International Ethics Standards Board of Accountants' Code of Ethics for Professional Accountants (IESBA Code) and the additional requirements applicable in Denmark, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### MANAGEMENT'S RESPONSIBILITIES FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with the Danish Financial Statements Act, and for such internal control as Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Management is responsible for assessing the Entity's ability to continue as a going concern, for disclosing, as applicable, matters related to going concern, and for using the going concern basis of accounting in preparing the financial statements unless Management either intends to liquidate the Entity or to cease operations, or has no realistic alternative but to do so.

# Notes to the financial statements

## 1 Accounting policies

## Reporting class

This annual report has been presented in accordance with the provisions of the Danish Financial Statements Act governing reporting class B.

### Recognition and measurement

Assets are recognised in the balance sheet when it is probable as a result of a prior event that future economic benefits will flow to the Entity, and the value of the asset can be measured reliably.

Liabilities are recognised in the balance sheet when the Entity has a legal or constructive obligation as a result of a prior event, and it is probable that future economic benefits will flow out of the Entity, and the value of the liability can be measured reliably.

On initial recognition, assets and liabilities are measured at cost. Measurement subsequent to initial recognition is effected as described below for each financial statement item.

Anticipated risks and losses that arise before the time of presentation of the annual report and that confirm or invalidate affairs and conditions existing at the balance sheet date are considered at recognition and measurement.

Income is recognised in the income statement when earned, whereas costs are recognised by the amounts attributable to this financial year.

### Consolidation

Pursuant to section 110 of the Danish Financial Statements Act, the Entity has not prepared any consolidated financial statements.

### Other external expenses

Other external expenses include expenses relating to the Entity's ordinary activities.

### Income from investments in affiliated companies

Income from investments in affiliated companies includes the dividend received during the yaer.

### Financial income and expenses

These items comprise interest income and expenses, currency gains and losses, amortisation of loan costs and tax surcharge and tax relief under the Danish Tax Prepayment Scheme.

## Tax

Tax for the year, which consists of current tax for the year and changes in deferred tax, is recognised in profit/loss for the year by portion attributable to the profit for the year.

## Balance sheet

### Financial assets

Financial assets comprise unlisted equity investments measured at cost. Unlisted equity investments are written down to any lower net realisable value.

# Receivables

Receivables are measured at fair value on initial recognition and subsequently at amortised cost, usually equalling nominal value less any writedowns for bad debts.

#### Cash

The carrying amounts for cash and cash equivalents assumed to equal the fair value.

# **Payables**

Other payables are measured at amortised cost, which usually corresponds to nominal value.

# 3 Collateral provided and contingent liabilities

The Company is established in conjunction with a division of the former NC AX 1 ApS, and together with the other shareholders, The Company is jointly and several liable to the obligations of NC AX1 ApS at the time of the division, however the amount can not exceed DKK 1,867,316k corresponding to the capital contributed at the time of division. At the time of the division NC AX1 ApS had liabilities of DKK 104k.

The Entity is part of a National Danish joint taxation. As a consequence, the Company is liable, for any obligation to withhold tax on interest, royalties and dividends for jointly taxed companies. The liability only constitutes an amount to the share of the capital in the affiliated company which is owned directly or indirectly by the Company.
