Management's Review

Main activities

Breakaway Republic Ventures IVS started off as a business providing web-based services for alumni of Indian Institute of Technology based in the USA and Europe to order transcripts from the universities without the normal hazzled process of ordering bank drafts. This business is operated through its binavn company transcripts india.com IVS.

The other business stream, also incorporated under another binavn of Breakaway Republic Ventures IVS, is Sixx Paraply IVS. The company imports top-quality umbrellas from India and sells them online via a website, using marketing tools such as facebook.

Willingdon Marine IVS, another binavn of Breakaway Republic Ventures IVS, offers marine consultancy services to clients.

Development in activities and economic conditions

transciriptsindia.com IVS' sales were brisk in the beginning with lots of customer interest, however, interest dwindled after the launch, compounded by poor service delivery by the institutes. In addition, the government changed the monetary policy in India, due to which the USP of the business - automating payments via credit cards instead of having to order bank drafts (the usual process) - was made redundant as the institutes were forced by the government to start accepting online payments and credit cards. Sales were very poor at the end of the fiscal.

Sixx Paraply IVS' sales did not gain traction and the website did not have many visitors or paying customers. The sales figures continued to be poor since the launch in October 2016. A large inventory of items remains unsold.

Willingdon Marine has been dormant throughout the fiscal.

Events following the financial year end

The operations of transcriptsindia.com IVS have been stopped - the website has been closed down.

The operations of Sixx Paraply IVS have been stopped - the website has been closed down. The inventory of unsold umbrellas is planned to be sold via auction in mid 2017.

Willingdon Marine IVS has plans to enter actively into the consultancy business.
