Independent auditor's report

Opinion

We have audited the financial statements of Saga VII Management Invest GP ApS for the financial year 1 October 2019 – 30 September 2020, which comprise accounting policies, income statement, balance sheet and notes. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the financial position of the Company at 30 September 2020, and of the results of the Company's operations for the financial year 1 October 2019 – 30 September 2020, in accordance with the Danish Financial Statements Act.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) and additional requirements applicable in Denmark. Our responsibilities under those standards and requirements are further described in the "Auditor's responsibilities for the audit of the financial statements" section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Independence

We are independent of the Company in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) and additional requirements applicable in Denmark, and we have fulfilled our other ethical responsibilities in accordance with these rules and requirements.

Management's responsibilities for the financial statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with the Danish Alternative Investment Fund Managers, etc. Act and for such internal control as Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting in preparing the financial statements unless Management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance as to whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Management's review

Operating review

Principal activities of the company

Saga VII Management Invest GP ApS main activity is to be general partner of Saga VII Management Invest K/S.

Performance in the financial year

In 2019/20 Saga VII Management Invest GP ApS realised a profit of DKK 5,784, which is in line with management's expectations.

At 30 September 2020, the equity amounted to DKK 65,064, of total assets of DKK 82,798.

The company has assumed the general partner obligation in two limited partnerships. The obligation as of 30 September 2020 amounts to DKK 18.4 million. As the limited partners in the partnerships are well reputable investors, the general partner obligation is not considered a significant risk.

Events after the end of the accounting period

There have been no events after the end of the financial year that are considered of significance to the Annual Report.

Accounting policies

The Annual Report of Saga VII Management Invest GP ApS has been prepared in accordance with the Danish Financial Act for reporting class B companies.

The accounting policies applied are consistent with those of last year.

The Annual Report has been prepared in DKK.

Income Statement

Revenue

Revenue comprises General Partner interest and reimbursement of expenses and is recognized in the profit and loss statement with the amount relating to the accounting period.

External administration expenses

External administration expenses include expenses relating to the administration of the company including expenses to auditor and legal services.

Financial expenses

Financial expenses comprise interest expenses as well as surcharges under the on-account tax scheme, etc.

Tax on profit for the year

Tax for the year comprises current tax for the year, changes in deferred tax and adjustment to tax relating to previous years.

Balance sheet

Receivables

Receivables are measured at nominal value less write-downs for bad debt losses.

Corporation tax and deferred tax

Current tax payable and receivable is recognised in the balance sheet as tax computed on the taxable income for the year, adjusted for tax on the taxable income of prior years and for tax paid on account.

Deferred tax is recognised using the current tax rate on all temporary differences between the carrying amount and the tax value of assets and liabilities. Deferred tax assets are recognised if they can in all probability be utilised.

Liabilities

Liabilities are measured at amortised cost which usually is equivalent to nominal value.
