Independent auditor's report

To the limited partners of Saga VII EUR K/S

Opinion

We have audited the financial statements of Saga VII EUR K/S for the financial year 1 October 2019 - 30 September 2020, which comprise accounting policies, income statement, balance sheet, statement of changes in limited partners' capital, cash flow statement and notes. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the financial position of the partnership at 30 September 2020, and of the results of the partnership's operations for the financial year 1 October 2019 – 30 September 2020, in accordance with the Danish Financial Statements Act.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) and additional requirements applicable in Denmark. Our responsibilities under those standards and requirements are further described in the "Auditor's responsibilities for the audit of the financial statements" section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Independence

We are independent of the partnership in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) and additional requirements applicable in Denmark, and we have fulfilled our other ethical responsibilities in accordance with these rules and requirements.

Management's review

Main activity of the partnership

Saga VII EUR K/S (Saga VII EUR) is a fund-of-funds with a geographical focus on investments in Western Europe. Investments are mainly made in micro, small and mid market buy-out funds.

Performance in the financial year

The financial year resulted in a loss of EUR 1.8 million, corresponding to an IRR of -7.1%. Losses on investments in portfolio funds amounted to EUR 0.2 million. Administrative expenses in the form of management fee and fund operating expenses amounted to EUR 1.5 million.

This years result is in line with management's expectations.

In the financial year an aggregate amount of EUR 22.2 million was paid-in by the limited partners, bringing the accumulated paid-in capital to EUR 46.0 million, corresponding to 14.5% of the limited partners' committed capital. An aggregate amount of EUR 22.5 million was contributed to the portfolio funds etc. during the financial year, bringing total contributions to the portfolio funds etc. to EUR 42.2 million, corresponding to 17.5% of the commitments to the portfolio funds etc..

Special risk

Financial risk

The objective of Saga VII EUR is to supply risk capital to the portfolio funds, and also to their investments in competitive companies in the European small and mid market. The highest factor of risk is therefore the changes in the value of the companies in which Saga VII EUR's portfolio funds invest in, which to a significant extent depend on the valuations of comparable listed companies on the quoted market. The valuation of investments in portfolio funds is based on estimates and could therefore be connected with some degree of uncertainty.

Interest rate risk

Saga VII EUR is less sensitive to the changes in interest rate levels.

Foreign exchange currency risk

Saga VII EUR's investments in portfolio funds and co-investments have been made in EUR, GBP and CHF. As the capital in Saga VII EUR is in EUR, Saga VII EUR is influenced by currency fluctuations in GBP and CHF. The currency risk is therefore considered as material. In accordance with Saga VII EUR's investment policy Saga VII EUR does not hedge its exposure toward currency rate fluctuations.

Investment activity

Saga VII EUR made two new commitments to portfolio funds in the financial year totalling EUR 104.8 million, bringing total commitments to portfolio funds and co-investment to EUR 242.0 million, corresponding to 76.3% of total commitments to Saga VII EUR.

The portfolio funds and co-investment have performed as expected.

Cash resources

Saga VII EUR's cash resources as of 30 September 2020, include cash and cash equivalents, undrawn credit facilities and outstanding commitments from the limited partners and are estimated as satisfactory to cover Saga VII EUR's liabilities.

Management's review

Expectation for 2020/21

The year 2020 has been drastically impacted by COVID-19, which led to almost unprecedented health and economic uncertainty. As a result, private equity activity experienced a sharp fall in Spring when uncertainty was at its peak, but has since rebounded along with the rest of the market and economic activity in general. Although certain sectors such as travel, tourism, and restaurants are still vey negatively impacted by the pandemic, other sectors such as IT and software are generally performing strongly. Going into 2021, optimism about a COVID-19 vaccine is high, and the expectation is that the market will further stabilize and strengthen as a vaccine hopefully soon becomes widely available.

Due to the nature of a fund-of-fund a loss is expected in the beginning of the fund's life time mainly due to management fee and fund operating expenses on Saga VII EUR and portfolio funds level.

The above-mentioned will affect the result for 2020/21 which is expected to be higher than the current year.

Events after the end of the accounting period

Saga VII EUR made commitments of EUR 91 million to two portfolio funds and increased the commitment to an existing portfolio fund, bringing total commitments to portfolio funds and coinvestment to EUR 343.5 million, corresponding to 108.4% of total commitments.

There have been no other events after the end of the financial year and to the signing of the annual report which are considered of significance to the annual report.

Accounting policies

The annual report of Saga VII EUR K/S has been prepared in accordance with the Danish Financial Statements Act for a reporting class B entity with the adjustments following the legal form and operating activities of the partnership.

The accounting policies applied are consistent with those of last year.

The annual report has been prepared in the functional currency EUR.

Income Statement

Gains/losses on portfolio funds' investments etc.

Gains/losses on portfolio funds' investments include income from investments (dividend and interest), realised and unrealised revaluations or depreciations of investments in portfolio funds as well as realised and unrealised exchange rate profit margins and losses related to the investment in portfolio funds etc.

Management fees and carried interest

The management fees and carried interest include management fee and carried interest for the period according to the Limited Partnership Agreement.

Fund operating expenses

Fund operating expenses include cost incurred by the partnership.

Financial income and expenses

Financial income and expenses include interest as well as exchange gains and losses related to accounts receivable and payable.

Tax

The partnership is not independently liable to tax, and therefore no tax is charged to the profit and loss account.

Accounting policies

Balance sheet

Investments assets

Investments in portfolio funds and co-investments are measured in accordance with the IPEV Valuation Guidelines or similar guidelines depending on the country of domicile of the portfolio funds, according to which investments are measured at fair value. Revaluations are included in the profit and loss account.

Investments in unlisted private equity funds are valued on the basis of the latest reporting received from the respective sub-funds. The reports from the funds contain a valuation of the private equity fund, including a valuation of each individual portfolio company. The value of a private equity fund consists of the sum of the values of the portfolio companies in which the fund has invested in, and the value of other net assets.

Outstanding investment commitments at the balance sheet date are disclosed as contingent liabilities in the notes.

Prepayments

Prepayments include paid costs relating to subsequent financial years. Prepayments primarily relates to prepaid management fee to the manager. Prepayments are measured at cost.

Cash and cash equivalents

Cash and cash equivalents include cash funds in open accounts and fixed short term loans.

Other payables

Financial liabilities are recognised at the date of borrowing at the net proceeds received less transaction costs paid. In subsequent periods, the financial liabilities are measured at fair value.

Other payables include potential carried interest and fund operating expenses due. Liabilities are measured at net realised value.

Foreign currency translation

Transactions in foreign currency are translated into Euro (EUR) according to the currency exchange rate at the transaction date. Investments, accounts receivable and accounts payable in foreign currency are translated into Euro (EUR) according to the currency rate at the balance sheet date.

Investments in portfolio funds

The partnership has through investments in portfolio funds ownership of mainly unquoted investments. The partnership has no controlling or significant influence on the portfolio funds in which the partnership has invested.

The portfolio funds in which the partnership has invested all use common accepted guidelines for measuring the fair value. The measuring of the fair value of the investments in underlying portfolio companies are made by the managers of the portfolio funds.

Usually the partnership has no or very little information about specific methods and assumptions used by the managers of the portfolio funds when measuring the fair value of the underlying portfolio companies.

The manager's valuation committee will assess and if considered necessary adjust the valuation of the underlying portfolio companies. At the assessment of the fair value of the underlying portfolio companies reported by the managers, information about the market conditions, company specific information as well as information received through dialog with the managers of the portfolio funds are used.

The value of a private equity fund is measured as the fair value of each investment in portfolio companies owned by the fund with addition of other net assets in the fund. The valuation of a portfolio company in a private equity fund is based on the industry, market position and earnings capacity, and the (i) the peer group multiple, i.e. the market value of comparable listed companies, (ii) transaction multiple in recent M&A transactions involving comparable companies, (iii) value indications from potential buyers of the portfolio company, (iv) market value if the portfolio company is publicly traded or (v) future expected proceeds, if there is a concluded agreement on the sale of the portfolio company.

1 Investments in portfolio funds (continued)

The partnership invests in buy-out funds. The investments made by the portfolio funds are classified within the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described below:

Level 1 – Inputs based upon priced for identical assets and liabilities in active markets

Level 2 – Inputs other than quoted prices that are observable for the asset or liability either directly or indirectly, including inputs in markets that are not considered to be active

Level 3 - Unobservable input


