Independent auditor's report

Opinion

We have audited the financial statements of Saga IV GP ApS for the financial year 16 October 2018 - 30September 2019, which comprise accounting policies, income statement, balance sheet and notes. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the financial position of the Company at 30 September 2019, and of the results of the Company's operations for the financial year 16 October 2018 – 30 September 2019, in accordance with the Danish Financial Statements Act.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) and additional requirements applicable in Denmark. Our responsibilities under those standards and requirements are further described in the "Auditor's responsibilities for the audit of the financial statements" section of our report. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Independence

We are independent of the Company in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) and additional requirements applicable in Denmark, and we have fulfilled our other ethical responsibilities in accordance with these rules and requirements.

Management's responsibilities for the financial statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with the Danish Alternative Investment Fund Managers, etc. Act and for such internal control as Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting in preparing the financial statements unless Management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Management's review

Operating review

Principal activities of the company

Saga IV GP ApS main activity is to be general partner of Saga IV EUR-A K/S, Saga IV EUR-B K/S, Saga IV USD-A K/S and Saga IV USD-B K/S.

Performance in the financial year

In 2018/19 Saga IV GP ApS realised a profit of DKK 115,260, which is in line with management's expectations.

In accordance to the Tax Act § 3 taxable income is transferred to the parent fund "Fonden af 16. Oktober 2018" which is a non-profit foundation and therefor the result of the year do not trigger payable tax.

At 30 September 2019, the equity amounted to DKK 165,260, of total assets of DKK 183,077.

The company has assumed the general partner obligation in four limited partnerships. The obligation as of 30 September 2019 amounts to DKK 447 million. As the limited partners in the partnerships are well reputable investors, the general partner obligation is not considered a significant risk.

Events after the end of the accounting period

There have been no events after the end of the financial year that are considered of significance to the Annual Report.

Accounting policies

The Annual Report of Saga IV GP ApS has been prepared in accordance with the Danish Financial Act for a reporting class B entity.

The Annual Report has been prepared in DKK.

Income Statement

Revenue

Revenue comprises General Partner interest and is recognized in the profit and loss statement with the amount relating to the accounting period.

Staff costs

Staff costs include the remuneration to the Management Board.

Financial expenses

Financial expenses comprise interest expenses as well as surcharges under the on-account tax scheme, etc.

Financial income and expense

Financial income and expenses comprise interest income and expenses as well as surcharges and refunds under the on-account tax scheme, etc.

Tax on profit for the year

The company is jointly taxed with Saga I GP ApS, Saga II GP ApS, Saga III GP ApS, Saga V GP ApS and Saga VI GP ApS. The company Saga VI GP ApS is the administration company for the joint taxation.

Tax for the year comprises current tax for the year, changes in deferred tax and adjustment to tax relating to previous years. The Corporation tax for the joint taxation is paid according to the simultaneous payment of company tax.

Balance sheet

Corporation tax and deferred tax

Current tax payable and receivable is recognised in the balance sheet as tax computed on the taxable income for the year, adjusted for tax on the taxable income of prior years and for tax paid on account.

Deferred tax is recognised using the current tax rate on all temporary differences between the carrying amount and the tax value of assets and liabilities. Deferred tax assets are recognised if they can in all probability be utilised.

Dividend

Proposed dividends are recognized as an obligation as it is approved at the Annual General Meeting of the Company. Dividend distribution proposed by Management for the year is disclosed as s separate equity item.

Liabilities

Liabilities are measured at amortised cost which is usually equivalent to nominal value.

1 Staff costs

The staff costs relate to the Management board. The company has no employee except for the Management board.

2 Contingencies, etc.

The company's contingent liabilities consist of the company's general partner obligation in Saga IV EUR-A K/S, Saga IV EUR-B K/S, Saga IV USD-A K/S and Saga IV USD-B K/S. As of 30 September 2019 the obligation amounts to DKK 447 million.

The company is jointly taxed with Saga I GP ApS, Saga II GP ApS, Saga III GP ApS, Saga V GP ApS and Saga VI GP ApS and are jointly and severally liable for the tax on the Group's jointly taxed income and the settlement thereof.
