# **Opinion**

We have audited the financial statements of Sif Property Holding ApS for the financial year 1 January – 31 December 2020 comprising income statement, balance sheet, statement of changes in equity and notes, including accounting policies. The financial statements are prepared in accordance with the Danish Financial Statements Act.

In our opinion, the financial statements give a true and fair view of the Company's assets, liabilities and financial position at 31 December 2020 and of the results of the Company's operations for the financial year 1 January – 31 December 2020 in accordance with the Danish Financial Statements Act.

# **Basis for opinion**



### 1 Accounting policies

The annual report of Sif Property Holding ApS for 2020 has been prepared in accordance with the provisions applying to reporting class B entities under the Danish Financial Statements Act with opt-in from higher reporting classes.

The accounting policies used in the preparation of the financial statements are consistent with those of last year.

## Income statement

#### **Gross loss**

Pursuant to section 32 of the Danish Financial Statements Act, the Company has decided only to disclose gross profit/loss. Gross loss comprise other external costs.

#### Other external costs

Other external costs comprise administration costs.

# Financial expenses

Financial costs comprise interest expenses and other financial costs.

### Tax on loss for the year

Tax for the year comprises current corporation tax for the year and changes in deferred tax, including changes in tax rates. The tax expense relating to the profit/loss for the year is recognised in the income statement at the amount attributable to the profit/loss for the year and directly in equity at the amount attributable to entries directly in equity.

#### **Balance sheet**

#### Receivables

Receivables are measured at amortised cost.

Write-down is made for bad debt losses where there is an objective indication that a receivable or a portfolio of receivables has been impaired. If there is an objective indication that an individual receivable has been impaired, write-down is made on an individual basis.

#### Cash at bank and in hand

Cash at bank and in hand comprises cash at bank.

### 1 Accounting policies (continued)

# Corporation tax and deferred tax

Current tax payable and receivable is recognised in the balance sheet as tax computed on the taxable income for the year, adjusted for tax on the taxable income of prior years and for tax paid on account.

Deferred tax is measured using the balance sheet liability method on all temporary differences between the carrying amount and the tax value of assets and liabilities based on the planned use of the asset or settlement of the liability.

Deferred tax assets, including the tax value of tax loss carryforwards, are recognised at the expected value of their utilisation within the foreseeable future; either as a set-off against tax on future income or as a set-off against deferred tax liabilities in the same legal tax entity. Any deferred net assets are measured at net realisable value.

Deferred tax is measured in accordance with the tax rules and at the tax rates applicable at the balance sheet date when the deferred tax is expected to crystallise as current tax. Changes in deferred tax as a result of changes in tax rates are recognised in the income statement or equity, respectively.

#### Liabilities

Other liabilities are measured at net realisable value.

### Contingent liabilities

In 2020, the Company has entered into a purchase agreement with Selskabet af 11. september 2014 ApS, CVR no. 36 04 43 81, CBH II ApS, CVR no. 32 35 55 36, US HOLDING, HORSENS ApS, CVR no. 29 84 83 51 and AKTIESELSKABET CBH, CVR no.27 51 23 56 to acquire the entire share capital of Domis Olof Palmes Alle ApS, CVR no. 35 80 82 21. Domis Olof Palmes Alle ApS is the registered owner of the property, title no. 13d, Arhus Markjorder, Olof Palmes Alle 11B, DK-8200 Aarhus N. The Company will enter into a turnkey contract with JCN Bolig A/S for the development and construction of the property, which will expectedly consist of 319 student housing units with a total floor area of approx. 9,537 square metres. The Company will take over the shares upon completion of the development project from the Seller when the Seller has concluded the construction hereof, expectedly by 15 January 2023.

The Company is subject to Danish scheme of joint taxation and unlimited jointly and severally liable with the other jointly taxed companies for the total corporation tax.
