## Independent auditor's report

#### To the shareholders of Gg Engvej E2 Propco P/S

#### **Opinion**

We have audited the financial statements of Gg Engvej E2 Propco P/S for the financial year 07.10.2021 - 31.12.2021, which comprise the income statement, balance sheet, statement of changes in equity and notes, including a summary of significant accounting policies.
